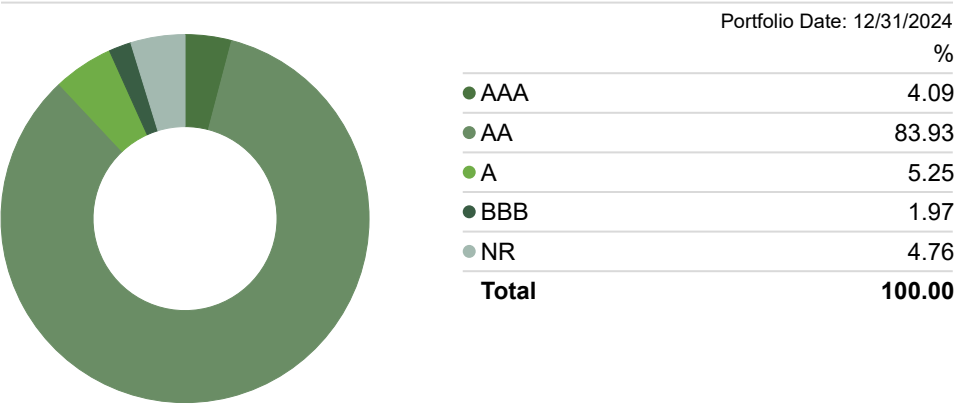
Investment Objectives

Credit Rating Breakdown



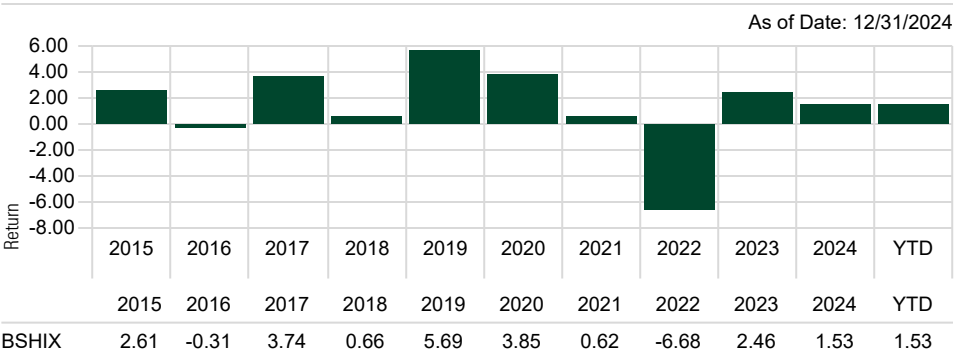
